Cape Town, South Africa — Britain's Financial Conduct Authority (FCA) is considering issuing an advisory circular (AC) in connection with initial coin offerings (ICO), following its December 2018 response to crypto investment recommendations from a group of international crypto regulators. The document was published Wednesday, May 22. According to the FCA, it would be the first of its kind in the UK market, where crypto regulations are rather underdeveloped. The regulator is also considering including it in its upcoming ICO assessment, the first of its kind in the country. The document suggests that the FCA could potentially "recommend that regulated entities take steps to manage any risks that arise" or that "we recommend that regulated entities adopt particular measures or procedures to avoid conducting certain types of activities." The announcement is also notable because the FCA is currently reviewing its cryptocurrency guidelines, which will affect all the UK's crypto companies. The agency has already recommended that UK crypto businesses register with it by April 1. The document is rather limited, containing just four recommendations: Recommendation A — No person, or group of persons should solicit, or offer or undertake, investment in an ICO, or provide investment advice to people who intend to invest in an ICO, without having the necessary professional qualification, experience or expertise, or without appropriate business and corporate governance arrangements. Recommendation B — UK-based ICOs, in particular, should register with the FCA before the launch of their offering. The FCA will evaluate all ICOs to establish if they are sufficiently compliant. Recommendation C — Under UK law, it is an offence for a person to act or solicit in a misleading or deceptive way in connection with offering or providing financial services to consumers. Therefore, any ICO must, at a minimum, comply with applicable consumer protection law. Recommendation D — Once an ICO has been completed, and has been published on an electronic trading platform or exchange, the FCA must be provided with a range of information concerning the ICO to assess whether it is being conducted responsibly. The document also mentioned the FCA's recent report on distributed ledger technology
